- A. Murphy Creek Master there is currently \$26,661.15 in the operating account and \$64,786.58 in the money market/CD account for a total of \$91,447.73.
- B. Murphy Creek Master operating expenses are over Budget \$(8,011.11) year-to-date.
- C. Murphy Creek Master delinquencies total \$63,247.53, of that amount, only \$12,222.76 is dues and \$24,903.87 legal, and the rest are late charges and violations.

- D. Michael Sheldon motioned and Cris Alexander seconded to write the balance owed off to bad debt on property 23760 E. Mississippi Cir. due to foreclosure. Motion passed unanimously, account has been updated.
- E. Cris Alexander motioned and Charles Bransfield seconded to write the balance off to bad debt on property 24621 E. Kansas Cir. due to foreclosure. Motion passed unanimously, account has been updated.

- F. Charles Bransfield motioned and Scott Alpert seconded to write the balance off to bad debt on property 24582 E. Louisiana Cir. due to foreclosure. Motion passed unanimously, account has been updated.
